There will be plenary talks, exhibitions, roundtables, workshops, teaching demos, and paper presentations by K-16 teachers. We estimate that over 300 Chinese language teachers and researchers from all around the world will register for and attend the Conference.

In the reserved space for exhibitors, publications, programs, and products may be sold on site. To reserve exhibition tables, please go to (<u>http://clta-us.org/clta-annual-conference/</u>). In order to accommodate different sponsors' needs and interests, we have come up with two ways for participating as an Exhibitor:

(1) Virtual Exhibitors: The fee is \$600 and includes (a) Inclusion on a sponsors list that will be widely promoted and distributed to CLTA members and communities through various channels including the CLTA conference website, listserv, 16 regional

associations, 13 CLTA-SIGs and their social media groups, and the CLTA general membership meeting (b) Exhibitor's promotional materials (e.g. name, logo, advertisement, website...etc.) will be posted on the 2023 CLTA Conference website (c) The list of Exhibitors will be recognized and thanked at the general membership meeting & dinner banquet (Saturday, 4/1) and the list will also be published and thanked in the CLTA Newsletter (May 2023 Issue).

(2) Onsite Exhibitors: The fee for one table is \$1,200 and includes the benefits (a), (b), and (c) provided to virtual Exhibitors and described above, PLUS (d) one onsite display exhibition table (in the Calvin Run Room) & one conference registration. Each additional representative will need to register for the conference (conference registration: early bird rate through 12/31/2022, and advanced rate until 1/31/2023). All events, including meals, will take place in the same hotel, and the registration fee includes one dinner (Saturday banquet) and two lunches (Fri & Sat) (e) One time slot (30 min) at the Exhibition presentation session. The Exhibition presentation session time is specifically reserved for Exhibitions. That is, no other presentations are scheduled in that time so that participants will be able to go to the Exhibition presentation session. The Exhibition presentation session is scheduled to be held on April 2 (Sunday) 8:30AM-9:30AM. If you reserve two Exhibition tables, you will have two time slots (one hour) for your presentation. The exhibition presentation activities for your presentation time slot(s) are very flexible. You can decide how to use them. For example, you might want to have a short introduction of your company/organization, invite your book authors do a presentation or simply host a Q and A session with the audience. (f) You can reserve your hotel rooms at the group rate for conference participants at the website.
